Important Questions	Answers	Why This Matters:
What is the overall deductible?	In-Network \$0 person / \$0 family, Out-of-Network \$200 person / \$500 family.	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible?	Yes. In-Network preventive care , emergency services, and services that require a copay . There is no In-Network deductible for this plan .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . Are there other deductibles for specific services?	Yes. \$500 deductible for prescription drug costs. There are no other specific deductibles .	You must pay all of the costs for these services up to the specific deductible amount before this plan begins to pay for these services.
What is the out-of-pocket limit for this plan?	In-Network coinsurance limit: \$800 person / \$2,000 family. For In-Network providers \$4,639 person / \$8,878 family, for Out-of-Network out-of-pocket limit: \$5,000 person / \$12,500 family.	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit?	Premiums , balance-billed charges, health care this plan doesn't cover, and preauthorization penalties.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
Will you pay less if you use a network provider?	Yes. See www.amerhealth.com/tpa or call: 1-844-352-1706 for a list of In-Network providers .	This plan uses a provider network . You will pay less if you use a provider in the plan's network . You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Do you need a referral to see a specialist?	No.	You can see the specialist you choose without a referral .

Does this plan provide Minimum Essential Coverage? **Yes**
